The Rector, pursuant to Section 71 et seq. of Act No. 111/1998 Coll., on Higher Education and on Amendments and Additions to Other Acts (the Higher Education Act), as amended, and further pursuant to the Rules of the Habilitation Procedure and the Procedure for the Appointment of Professors of the Academy of Arts, Architecture and Design in Prague dated 13 December 2018, has issued the following Directive:

Habilitation Procedure at the Academy of Arts, Architecture & Design in Prague

Rector's Directive No. 5/2023 of 11 May 2023

I Introductory Provisions

- The Habilitation Procedure is governed by Section 71 and subsequent sections of Act No. 111/1998 Coll., on Higher Education and on Amendments and Additions to Other Acts (the Higher Education Act), as amended (hereinafter referred to as the "Act"), and Rules of the Habilitation Procedure and the Procedure for the Appointment of Professors at the Academy of Arts, Architecture and Design in Prague (hereinafter referred to as UMPRUM).
- 2. The Habilitation Procedure can be conducted at UMPRUM in the accredited disciplines of Architecture and Design, Fine Arts, and Theory and History of Modern and Contemporary Art.
- 3. This Directive establishes the procedure for the Habilitation Procedure at UMPRUM.

II Requirements for the Application to Commence the Habilitation Procedure in the Fields of Architecture and Design and Fine Art

- 1. The applicant shall attach the following documents to the application for the commencement of the Habilitation Procedure pursuant to Section 72(2) and (3) of the Act:
 - a. Habilitation thesis documentation of outstanding artistic activity, or an artwork, or a collection of works, or a monograph supplemented with a text part; If the habilitation thesis is a collective work, the applicant's contribution must reach at least 50 %.
 - b. Self-evaluation of the applicant in the form of a table of achieved quantified evaluation criteria (Annexes No. 4 or 5 of the Directive);
 - c. Overview of significant published works, implemented architectural or artistic works including their brief characteristics or basic documentation and the percentage share of the applicant in case of collective works (structured according to Annexes No. 7 or 8, part A of the Directive);
 - d. Overview of responses of works with indication of citation sources (structured according to appendices
 No. 7 or 8, part B of the Directive);
 - e. Overview of pedagogical and other professional activities (structured according to Annexes No. 7 or 8, part C of the Directive);

The overview of pedagogical activities must be confirmed by the current or last employer.

- f. Structured professional CV;
- g. Officially certified copies of documents proving university education and obtained degrees;
 - Official verification means either notarial or registry office certification, or a statement by an authorised staff of the relevant department of the academy confirming that the copy corresponds to the original, certified by an official stamp and signature of this staff.
- h. Confirmation from the employer certifying continuous pedagogical practice at a domestic or foreign higher education institution with a total scope corresponding to full-time employment for a minimum period of 3 years. Part-time contracts are added together.
- 2. The applicant shall attach the following documents to the application for commencement of the Habilitation Procedure:
 - a. Originals or copies of the most significant publications, materials showing artworks, models, documentation;
 - b. Pedagogical concept in the extent of 3 standard pages;
 - c. Title and a brief annotation of the habilitation lecture topic.

 Through the habilitation lecture, the applicant demonstrates their pedagogical competence in the given field. The applicant shall demonstrate in the lecture their ability to reflect on general issues and current developments in their discipline. In this context, they will present the results of their own creative work and pedagogical activities. In the subsequent discussion, they shall demonstrate the ability to face critical comments and defend their theses. The duration of the habilitation lecture is 20—25 minutes.
- 3. Documents specified in points 1a—f, 2b—c shall be submitted in two copies in total, of which 1x in paper form and 1x in electronic form for the reviewers opponents. Other documents shall be submitted in one copy in paper form.
- 4. The applicant is responsible for the factual, linguistic and formal correctness of the submitted documents.

III Requirements for the Application to Commence the Habilitation Procedure in Theory and History of Modern and Contemporary Art

- 1. The applicant shall attach the following documents to the application for the commencement of the Habilitation Procedure pursuant to Section 72(2) and (3) of the Act:
 - a. The habilitation thesis in the form of a professional monograph or a comprehensive collection of studies with an introduction, in the recommended minimum length of 150 standard pages, published as a book or in the form of a bound typescript;
 - The focus of the thesis must correspond to the field of the Habilitation Procedure and must not overlap with the content of the dissertation thesis.
 - b. Self-evaluation of the applicant in the form of a table of achieved quantified evaluation criteria (Annex No. 6 of the Directive);
 - c. Overview of significant published works scholarly monographs and chapters, original studies in peer-reviewed journals, etc. related to the applicant's professional activities (structured according to Appendix No. 9, part A of the Directive);

- d. Overview of demonstrable professional response (citations) structured according to Annex No. 9, part B of the Directive;
- e. Overview of scientific research and other professional activities (structured according to Appendix No. 9, part C of the Directive);
- f. Overview of pedagogical activities (structured according to Appendix No. 9, part D of the Directive);
 - The overview of pedagogical activities must be confirmed by the current or last employer.
- g. Structured professional CV;
- h. Officially certified copies of documents proving university education and obtained degrees;
 - Previous acquisition of a Ph.D. degree or equivalent scientific title is required. Official verification means either notarial or registry office certification, or a statement by an authorised staff of the relevant department of the academy confirming that the copy corresponds to the original, certified by an official stamp and signature of this staff.
- i. Confirmation from the employer certifying continuous pedagogical practice in the position of Assistant Professor at a domestic or foreign university corresponding to a full-time position for a minimum period of 3 years. Parttime contracts are added together.
- 2. The applicant shall attach the following documents to the application for commencement of the Habilitation Procedure:
 - a. Titles and brief annotations of three habilitation lecture topics. Through the habilitation lecture, the applicant demonstrates their pedagogical competence in the given field. The applicant shall demonstrate in the lecture their ability to reflect on general issues and current developments in their discipline. In this context, they will present the results of their own professional and pedagogical activities. In the subsequent discussion, they shall demonstrate the ability to face critical comments and defend their theses. The duration of the habilitation lecture is 20—25 minutes.
- 3. Documents specified in points 1 a-g and 2 a shall be submitted in two copies in total, with 1 copy in paper form and 1 copy in electronic form for the opponents. Other documents shall be submitted in one copy in paper form.
- 4. The applicant is responsible for the factual, linguistic and formal correctness of the submitted documents.

IV Assessment of the Application for Commencement of the Habilitation Procedure

- 1. The applicant submits to the Rector a proposal for the commencement of the Habilitation Procedure together with the documents specified in Article II or III of the Directive. If the Rector finds the proposal satisfactory, the Habilitation Procedure is commenced. The applicant shall be notified in writing of the commencement of the Habilitation Procedure within one month from the date of submission of the application for the commencement of the Habilitation Procedure.
- 2. If the proposal does not have all the necessary requirements and the applicant fails to remedy its deficiencies within three months from the date of delivery of the written request for remedy, the Rector shall terminate the Habilitation Procedure.

V Habilitation Committee

- 1. Members of the habilitation committee cannot include persons with potential bias in assessing the proposal, nor co-authors of the work submitted as the habilitation thesis.
- 2. The Chair and Members of the Habilitation Committee will receive information about the composition of the Habilitation Committee and the complete documentation submitted by the applicant in electronic form.
- 3. If the Chair or a member of the Habilitation Committee requests to be relieved of their duties, the election of the entire Committee is repeated at the next session of the artistic council, or a correspondence form of voting is used.
- 4. The assessment of the materials submitted by the applicant and the appointment of reviewers for the Habilitation thesis may take place at a meeting of the Habilitation Committee, attended by at least four of its members, either in person or online.
- 5. If the proposal for appointment does not receive a majority of votes from all members of the Habilitation Committee, the Committee will recommend halting the Habilitation Procedure. The decision to halt will be made by the Artistic Council. The applicant may express their opinion on the opponent's reports and the standpoint of the Habilitation Committee before the vote of the Artistic Council.
- 6. The applicant may withdraw their application for the commencement of the Habilitation Procedure at any stage of the process, by means of a written notification. In such a case, the Rector terminates the procedure, and the applicant's documents attached to the application pursuant to Article II or Article III of the Directive are returned.

VI

Course of the Habilitation Procedure at the Meeting of the Artistic Council

- 1. Procedure at the Artistic Council meeting:
 - a. Commencement of the Habilitation Procedure;
 - b. Introduction of the candidate by the Rector or authorised Vice-Rector;
 - c. Presentation of the opinion of the Habilitation Committee by the Chair of the Committee or a member authorised by them;
 - d. Presentation of substantial parts of opponent reviews and questions from opponents to the candidate;
 - e. Habilitation lecture by the applicant (duration 20–25 minutes)
 - f. Public discussion on the submitted work and its presentation, on the level of achieved results, pedagogical concept, contribution to the development of the field and UMPRUM, comparison with the development of the field on a European and global scale;
 - g. Closed meeting of the members of the Artistic Council, Habilitation Committee and opponents;
 - h. Secret ballot of the present members of the Artistic Council on the proposal;
 - i. Report of the vote counters;
 - j. Formulation of the conclusion;
 - k. Immediate public announcement of the results of the Habilitation Procedure by the Rector.
- 2. If the applicant for the Habilitation Procedure is also a member of the UMPRUM Artistic Council, they shall not participate in the voting of the Artistic Council.
- 3. The habilitation lecture can only be delivered in Czech or Slovak language.

- 4. An applicant who has not received a sufficient number of votes from all members of the Artistic Council in the Habilitation Procedure and has not been proposed for appointment as associate professor may submit another application to commence the Habilitation Procedure, however no sooner than one year after the termination of the previous the Habilitation Procedure. The habilitation thesis and habilitation lecture must address a new topic.
- 5. An application for the commencement of the Habilitation Procedure may be submitted no more than twice in total.

VII Other Provisions

- 1. UMPRUM publishes information about the commencement and completion of the Habilitation Procedure, including the dates of relevant public meetings of the Artistic Council, in the public section of its website in accordance with the law.
- 2. A basic fee determined by the Rector's decision is set for conducting the Habilitation Procedure to cover the expenses associated with the procedure. The applicant shall pay this fee by bank transfer after the Habilitation Committee has been appointed and approved by the Artistic Council.

This Directive repeals the Rector's Directive No. 02/2021 of 26 January 2021.

3. This Directive comes into force and effect on the date of its publication.
